



Article 1 – Definition of a child: All children under 18 have all the rights in the Convention

Article 4 – Making rights real: Governments must do all they can to make sure every child can enjoy their rights by creating systems and passing laws that promote and protect children's rights.



EXPLORING ARTICLES 1 & 4

We all have human rights. Why is the UN Convention on the Rights of the Child important as well?

HOW MANY OF THESE DID YOU GET?

- Children and young people need a set of rights just for them because childhood is a time where children and young people need special consideration and protection as they grow.
- The Convention is an agreed set of standards so we all know what children need and are entitled to so they can grow up healthy and safe.
- The Convention gives the world a vision or a goal for how life should be for children everywhere.
- Children have less power to make decisions than adults so they need to be given a say in decisions affecting them.
- Children need special protection from harm as they may not be as big or strong as adults.
- Children need a good quality education to help them have a good life and this is guaranteed by the Convention.
- The Convention ensures and encourages governments to help children for example, families often need extra support from government to look after their children.

ACTIVITY TIME

The Commissioners for Children and Young People are required by law to protect and promote your rights. Find out who they are in your country and what they do.

Pick one of the other rights that you know about, and think about how a baby, a 10-year-old and a 17-year-old could enjoy that right.
What different help might they need? Who from?

Create a poster, song or poem to show that rights are for all children around the world. Perhaps you could display or perform you artwork on World Children's Day?

Only one country in the world hasn't signed up to say it will protect children's rights*. Do you know which one it is? Can you find it on a map?

Listen to this song from Glade Primary
School – which words do the children sing which show that rights are for ALL children?

Think about what might stop children from enjoying their rights. Create an obstacle course outside or a simple board game to show how these obstacles need to be removed or overcome.

REFLECTION

Try to find somewhere peaceful and spend a few minutes being quiet and still ... then think about these questions...

Article 1 defines children as everyone under the age of 18.

- Do you think 18 is the right age?
- Do you think children's rights should be realised differently depending on age? Can you think of any examples?
- What happens when you reach 18? What role should rights play in your life then?





EXTENSION

Imagine a world where EVERY child and young person can access and enjoy all they rights.

Talk about this with a friend or create a piece of poetry or art to celebrate how this might look and feel.
